

MEMORANDUM
on Mutual Understanding for Cooperation
between WFS Building gUG and the Communal State Institution "Aktobe Service College"
of the State Institution "Department of Education of Aktobe Region"

1. General Provisions

In order to strengthen friendly exchange and cooperation between the two parties, guided by the principles of mutual benefit and joint development, and following amicable negotiations, the parties have reached the following agreement:

1. Objectives of Cooperation

In the field of training specialists in automotive transport professions through dual education, the parties will deepen cooperation in the development of educational programs, academic exchange of teachers and students, enhancement of students' professional skills, integration of international specialties, and meeting the demand for engineering and teaching personnel.

2. Scope of Cooperation

Joint Development of Educational Programs

Party A and Party B will jointly develop educational standards, materials, and industry regulations for the development of specialties in the fields of maintenance and repair of modern automobiles. Party A will assist in the implementation of these technical resources into the educational processes of Party B.

Party A and Party B will organize online and offline trainings and seminars, inviting German and Kazakh experts to improve the practical skills of teachers. Party B will be responsible for assisting in the development of seminar programs, planning, etc., as well as coordinating the exchange visits between the two parties.

3. Student Exchange

The parties organize short-term exchanges and other programs during the summer holidays.

4. Cooperation Mechanism


Party A, as the sole representative of Party B in Germany, is responsible for the interaction between Parties A and B, the development of specific cooperation plans (for example, scheduling mutual teacher visits, etc.), and ensuring the synchronization of information between the two

parties. Party A also coordinates negotiations between the two parties on cooperation details (for example, organizing practical classes) and addresses any issues that arise during the implementation process.

5. Other Terms

C This Memorandum serves as an intentional framework document concluded for the purpose of strengthening comprehensive cooperation between the Parties and constitutes a fundamental basis for defining specific areas of collaboration. The Parties undertake to comply with its provisions in good faith. Specific terms of cooperation, including the content and methods of interaction, allocation of expenses, rights, and obligations, shall be determined separately. This Memorandum comes into effect on the date it is signed by both Parties. Specific cooperation projects shall be formalized in additional agreements, which are drafted by Party B and approved by both Parties.
